**The Parking and Waiting Restrictions (Belfast) (Amendment
No. 2) Order (Northern Ireland) 2025**

Made - - - - *19th November 2025*

Coming into operation - *15th December 2025*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

In accordance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 to the 1997 Order, the Department has consulted such persons as it considers appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Belfast) (Amendment No. 2) Order (Northern Ireland) 2025 and shall come into operation on 15th December 2025.

Amendment

2. The Parking and Waiting Restrictions (Belfast) Order (Northern Ireland) 2025^(d) is amended by the addition to Part 1 of Schedule 2 of the following—

“341. Marlborough Park (north side) – from a point 15 metres west of its junction with Malone Road for a distance of 19.3 metres in a westerly direction.”

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
