**The Parking Places on Roads (Coaches) (Amendment No. 2)
Order (Northern Ireland) 2025**

Made - - - - *3rd December 2025*

Coming into operation - *24th December 2025*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1), (13) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b), (“the 1997 Order”) and now vested in it^(c).

In accordance with Article 10(1) of the 1997 Order it appears to the Department to be necessary to provide a suitable parking place for buses and coaches on a length of road as specified in Article 2.

In accordance with Article 10(7) of, and paragraphs 1 and 2 of Schedule 4 to, the 1997 Order, the Department has consulted such persons as it considered appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

In compliance with paragraph 3(4) of Schedule 4 to the 1997 Order, the Department has taken such other steps as appear to it reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as the Parking Places on Roads (Coaches) (Amendment No. 2) Order (Northern Ireland) 2025 and shall come into operation on 24th December 2025.

Amendment

2.—(1) The Parking Places on Roads (Coaches) Order (Northern Ireland) 2015^(d) is amended in accordance with paragraph (2).

(2) For Schedule 6 substitute the Schedule set out in the Schedule to this Order.

Article 2

“SCHEDULE 6

Waiting only between 8.00 a.m. and 6.00 p.m. on Monday to Saturday limited to 30 minutes with no return within 1 hour

1.	Market Square South, Lisburn (south side) – from a point 24.75 metres west of its junction with Bridge Street for a distance of 28.4 metres in a westerly direction.
2.	Upper Edward Street, Newry (north-west side) – from a point 15 metres west of its junction with Cecil Street for a distance of 20 metres in a westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places on Roads (Coaches) Order (Northern Ireland) 2015 (“the Order”) by the addition to Schedule 6 of the item relating to Upper Edward Street, Newry.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
