**The Cycle Routes (Amendment No. 2) Order (Northern Ireland)  
2026**

*Made* - - - - 2026  
*Coming into operation* 2026

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> (“the 1997 Order”) and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considers appropriate in accordance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 of the 1997 Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

**Citation and commencement**

1. This Order may be cited as the Cycle Routes (Amendment No. 2) Order (Northern Ireland) 2026 and shall come into operation on 2026.

**Amendment**

2.—(1) The Cycle Routes Order (Northern Ireland) 2008<sup>(d)</sup> is amended in accordance with paragraph (2).

(2) In Schedule 2 after item no. 530 insert the following items—

- “531. The northern footway of Glenshane Road, Route B192, Dungiven from Dungiven Bridge for a distance of 630 metres in a westerly direction to a point opposite its junction with Feeny Road, Route B74, Dungiven, broken only by its junction with Drumrane Road, Route B192, Dungiven.
- 532. The northern footway of Foreglen Road, Route B192, Dungiven from a point opposite its junction with Feeny Road for a distance of 9695 metres in a westerly

direction to a point opposite its southern junction with Ballyhanedin Road, Route C517, Limavady, broken only by gaps for side roads and access purposes.”

### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends the Cycle Routes Order (Northern Ireland) 2008 (“the 2008 Order”) by the addition to Schedule 2 of a two-way shared cycle track on lengths of Glenshane Road and Foreglen Road, Dungiven as specified in Article 2(2).

Any person who acts in contravention of Article 2 of the 2008 Order by causing or permitting a vehicle other than a cycle to wait in a cycle lane shall be liable to a penalty charge (£90) payable in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Any person who contravenes any other provision of the 2008 Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 (“the Regulation Order”) and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£1,000) in accordance with the Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs and road markings indicating the effect of this Order will in due course be placed on the road.
