**The Parking Places on Roads and Waiting Restrictions
(Cookstown) (Amendment) Order (Northern Ireland) 2026**

Made - - - - 2026
Coming into operation 2026

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) (“the 1997 Order”) and now vested in it^(c).

In accordance with Article 4(6) of, and paragraphs 1 and 2 of Schedule 1 to, the 1997 Order, the Department has consulted such persons as it considered appropriate.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

Citation and commencement

1. This Order may be cited as the Parking Places on Roads and Waiting Restrictions (Cookstown) (Amendment) Order (Northern Ireland) 2026 and shall come into operation on 2026.

Amendment

2.—(1) The Parking Places on Roads and Waiting Restrictions (Cookstown) Order (Northern Ireland) 2018^(d) is amended in accordance with paragraph 2(2).

(2) In Part 1 of Schedule 2 after item no. 71 insert the following —

“71. Drum Road, Cookstown (north-east side) — from a point 380 metres north-west of its junction with Rectory Road for a distance 76 metres in a north-westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads and Waiting Restrictions (Cookstown) Order (Northern Ireland) 2018 (“the Order”) by the addition of a no waiting at any time restriction (loading and unloading permitted) on a length of Drum Road, Cookstown as specified in Article 2(2).

Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
