Background

The powers delegated to DfI Rivers by the Department for Infrastructure, as the statutory Drainage and Flood Defence authority for Northern Ireland, derive from the Drainage (Northern Ireland) Order 1973 which is the legislative basis for the delivery of capital work schemes.

This technical guidance note outlines the steps required by the Department to progress capital flood defence projects (schemes > £10m) from inception through to completion. The processes are set out within the document in a systematic way, with step-by-step guidance clearly defined at each stage of the project lifecycle. Internal gateway approvals, statutory requirements and best practice principles have been included within the guidance.

The audience for this guidance is primarily staff within the DfI Rivers Capital Projects Units and partnering consultants. This guidance will ensure a standardised and consistent approach is delivered by the Department and in line with best industry practices.
