The Parking and Waiting Restrictions (Omagh) (Amendment) Order (Northern Ireland) 2024

Coming into operation 2024

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

Citation and commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Omagh) (Amendment) Order (Northern Ireland) 2024 and shall come into operation on 2024.

Amendments

- **2.**—(1) The Parking and Waiting Restrictions (Omagh) Order (Northern Ireland) 2013(**d**) is amended in accordance with paragraphs (2) and (3).
- (2) In Article 1(2), for the definitions of "postal packet" and "universal service provider" substitute—

"postal packet" has the same meaning as in section 65(1) of the Postal Services Act 2011(e); and

"universal service provider" has the same meaning as in section 65(1) of the Postal Services Act 2011.

- (3) in Schedule 3 after item no. 17 add the following items—
 - "18. High Street (north side) from a point 14 metres south-east of its junction with Georges Street for a distance of 5 metres in a south-easterly direction.
 - 19. High Street (north-side) from a point 72 metres west of its junction with Bridge Street for a distance of 6 metres in a westerly direction.
 - 20. High Street (south side) from a point 72 metres west of its junction with Bridge Street for a distance of 4 metres in a westerly direction.
 - 21. Scarffe's Entry (east side) from a point 86 metres north of its junction with Kelvin Avenue for a distance of 5 metres in a north-westerly direction."
