The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

"x.	Sunnylands Avenue, Carrickfergus (east side) – from a point 99 metres south of its junction with Bridewell Drive for a distance of 5.5 metres in an easterly direction.
х.	Church View, Dromore, County Down (north side to the side of No. 20) – from a point 61 metres west of its junction with Church Street for a distance of 3 metres in a westerly direction.
х.	Maypole Park, Dromore, County Down (south-west side in front of No. 9) – from a point 115 metres north-west of its junction with Maypole Hill for a distance of 3 metres in a north-westerly direction.
х.	Mount Street, Dromore, County Down (north-east side) – from a point 85 metres east of its junction with Moss Lane for a distance of 6 metres in a south-easterly direction.
х.	Rooney Park, Kilkeel (north-west side in front of No. 22) – from a point 131 metres north-west of its junction with Rooney Road for a distance of 6 metres in a north-westerly direction.
х.	Fairway, Larne (north-east side) – from a point 78 metres east of its junction with Linn Road for a distance of 5.5 metres in an easterly direction.
X.	Elaghmore Park, Londonderry (north-east side of Unclassified No. 1520 stretch 5 in front of No. 53) – from a point 52.5 metres north-west of its junction with Elaghmore Park (stretch 86) for a distance of 3.6 metres in a north-westerly direction.
X.	Westway, Londonderry (north-west side in a parking area) – from a point 17 metres north-east of its junction with Dunmore Gardens for a distance of 3 metres in a north easterly direction.
х.	Lisgullion Park, Newry (south-east side) – from a point 80 metres south-east of its junction with Drumgullion Avenue for a distance of 3 metres in a south-easterly direction.
X.	Main Street, Sixmilecross (south-east side) – from a point 60 metres north-east of its junction with Meetinghouse Road for a distance of 6 metres in a north-easterly direction."

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the amendment of the item referred to in Article 2(2)(a).
