The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

#### Citation and commencement

1. This Order may be cited as the Parking Places on Roads and Waiting Restrictions (Dungannon) (Amendment No. 2) Order (Northern Ireland) 2023 and shall come into operation on 2023.

### Amendment

- **2.**—(1) The Parking Places on Roads and Waiting Restrictions (Dungannon) Order (Northern Ireland) 2018(**d**) is amended in accordance with paragraph (2).
- (2) In Part 1 of Schedule 2 insert the following items—
  - "67. Granville Industrial Estate (east side) from a point 15 metres north-west of its junction with Granville Road for a distance of 114 metres in a north-westerly and then northerly direction.
  - 68. Granville Industrial Estate (west side) from a point 68 metres north-west of its

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order amends The Parking Places on Roads and Waiting Restrictions (Dungannon) Order (Northern Ireland) 2018 ("the Order") by the addition of a no waiting at any time restriction (loading and unloading permitted) on lengths of Granville Industrial Estate as specified in Article 2(2). Vehicles are excepted from the restriction in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
