The Prohibition of Right-Hand Turn (Enniskillen) Order (Northern Ireland) 2023

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

Citation and commencement

1. This Order may be cited as the Prohibition of Right-Hand Turn (Enniskillen) Order (Northern Ireland) 2023 and shall come into operation on 2023.

Prohibition of right-hand turn

2. Subject to Article 3, a person shall not cause or permit any vehicle proceeding in a westerly direction on Dublin Road, Enniskillen to make a right-hand turn at a point 80 metres east of its junction with Derrychara Road.

Exceptions

3. The prohibition in Article 2 shall not apply to—

- (a) a vehicle being used for fire and rescue, ambulance, police or customs purposes or for the purposes of the security forces; or
- (b) a vehicle, the driver or rider of which is acting upon the direction, or with the permission, of a constable in uniform.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles travelling in a westerly direction along Dublin Road, Enniskillen from making a right-hand turn at a point 80 metres east of its junction with Derrychara Road.

Vehicles are excepted from the prohibition in certain circumstances (Article 3).

Any person who acts in contravention of this Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 ("the Regulation Order") and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (\pounds 1,000), in accordance with the Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs indicating the effect of the Order will in due course be placed on the road.
