The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

#### **Citation and commencement**

**1.** This Order may be cited as The Cycle Routes (Amendment No. 2) Order (Northern Ireland)2021 and shall come into operation on2021.

#### Amendments

**2.** The Cycle Routes Order (Northern Ireland) 2008(**d**) is amended by the addition to Schedule 2 of the following items—

- "xxx. The north-western footway of Frys Road and Broughshane Road, Ballymena from its junction with Deramore Park for a distance of 180 metres south-west of that junction.
- xxx. The northern footway of Raceview Road traffic island, Ballymena 4 metres distance on the traffic island in the centre of Raceview Road at its junction with the ECOS Roundabout.
- xxx. The southern footway of the grassed area between Frys Road and Raceview Road, Ballymena 15. 5 metres on the grass area between Frys Road and Raceview Road.

XXX.	The south-western footway of Grove Road, Ballymena from its junction with Millfield for a distance of 241 metres in a south westerly direction.

XXX.	The eastern footway of Doury Road, Ballymena from its junction with Grove Road for a distance of 134 metres in a southerly direction.
XXX.	The northern footway of Dunvale, Ballymena from its junction with Doury Road for a distance of 7 metres in an easterly direction.
XXX.	The southern footway of Dunvale, Ballymena from its junction with Doury Road for a distance of 7 metres in an easterly direction.
XXX.	The eastern footway of Doury Road, Ballymena from its junction with Dunvale for a distance of 242 metres in a southerly direction.
XXX.	The western footway of Old Ballee Link Road, Ballymena from its junction with Pennybridge Industrial Estate for a distance of 427 metres in a northerly direction.
XXX.	The south-western footway of Larne Road Roundabout, Ballymena from its junction with Old Ballee Link Road for a distance of 42 metres in a north-westerly direction.
XXX.	The southern footway of Larne Road Link, Route A26, Ballymena from its junction with Larne Road Roundabout for a distance of 180 metres in a north-westerly direction.

### **EXPLANATORY NOTE**

## (This note is not part of the Order)

This Order amends The Cycle Routes Order (Northern Ireland) 2008 ("the Order") by the addition to Schedule 2 of two-way shared cycle tracks on the lengths of footway specified in Article 2.

Any person who acts in contravention of Article 2 of the Order by causing or permitting a vehicle other than a cycle to wait in a cycle lane shall be liable to a penalty charge (£90) payable in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Any person who contravenes any other provision of the Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 ("the Regulation Order") and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale ( $\pounds$ 1,000) in accordance with The Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs and road markings indicating the effect of this Order will in due course be placed on the roads.
