**The Parking and Waiting Restrictions (Carrickfergus)
(Amendment No. 2) Order (Northern Ireland) 2021**

Made - - - - 2021

Coming into operation - 2021

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

Citation and commencement

1. This Order may be cited as The Parking and Waiting Restrictions (Carrickfergus) (Amendment No. 2) Order (Northern Ireland) 2021 and shall come into operation on 2021.

Amendments

2.—(1) The Parking and Waiting Restrictions (Carrickfergus) Order (Northern Ireland) 2016^(d) is amended in accordance with paragraphs (2) to (4).

(2) For Article 11 substitute the following Article—

“Lengths of road on which vehicles must not wait

11. Save as provided in Article 12, a person shall not cause or permit a vehicle to wait —

- (a) at any time on a length of road specified in Part 1 or Part 2 of Schedule 2;
- (b) during the hours between 8.00 a.m. and 6.00 p.m. on the days Monday to Friday inclusive on the length of road specified in Part 3 of Schedule 2;

- (c) during the hours between 10.00 a.m. to 11.00 a.m. and between 2.00 p.m. to 3.00 p.m. on the days Monday to Saturday inclusive on the length of road specified in Part 4 of Schedule 2; or
- (d) during the hours between 8.30 a.m. to 9.15 a.m. and between 1.00 p.m. to 4.00 p.m. on the days Monday to Friday inclusive, during the period from 31st August to 30th June on the length of road specified in Part 5 of Schedule 2.”

(3) In Part 1 of Schedule 2 after item 5 add the following item—

- “6. Rhanbuoy Close (both sides) – from a point 15 metres north-west of its junction with Belfast Road for a distance of 30 metres in a north-westerly direction.”

(4) After Part 4 of Schedule 2 insert the following—

“PART 5

No Waiting Monday to Friday 8.30 a.m. to 9.15 a.m. and 1.00 p.m. to 4.00 p.m.
(31st August – 30th June) – Loading and unloading not permitted

Maritime Drive (north-west side) – from a point 144 metres south-west of its junction with Rodgers Quay for a distance of 46 metres in a south-westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Carrickfergus) Order (Northern Ireland) 2016 (“the Order”) by substituting Article 11 to include the new waiting restrictions in Part 5 of Schedule 2 (Article 2(2)), the addition of a no waiting at any time (loading and unloading permitted) restriction on the lengths of Rhanbuoy Close specified in Article 2(3) and the addition to Schedule 2 of the waiting restrictions referred to in Part 5 of that Schedule (Article 2(4)).

Vehicles are excepted from the restrictions in certain circumstances.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
