**The Prohibition of Waiting (Schools) (Amendment No. 4) Order
(Northern Ireland) 2021**

Made - - - - 2021

Coming into operation - 2021

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

Citation and commencement

1. This Order may be cited as The Prohibition of Waiting (Schools) (Amendment No. 4) Order (Northern Ireland) 2021 and shall come into operation on 2021.

Amendment

2. The Prohibition of Waiting (Schools) Order (Northern Ireland) 2021^(d) is amended by the addition to Schedule 2 of the following item—

“52.	Maritime Drive, Carrickfergus (north-west side) – from a point 106 metres west of its junction with Rodgers Quay for a distance of 38 metres in a south-westerly direction.	8.30 a.m. to 9.15 a.m. and 1.00 p.m. to 4.00 p.m.	Monday to Friday inclusive	31st August to 30th June”

EXPLANATORY NOTE

(This note is not part of the Order)
