### 2B. Please explain how the Policy, Strategy, Plan or Public Service is likely to impact on people in rural areas.

High level options for consultation on water and sewerage charges have been developed at this point and early analysis indicates that charges are likely to impact negatively on people in rural areas. The planned consultation is intended to clarify the potential options in support of a conversation on how water and sewerage charges could be introduced in NI. The consultation is also the opportunity for citizens to explain potential impacts this proposal may have.

Options considered are as follows:

- Introduction of domestic water and sewerage charges
- Remove the Domestic Allowance for Non Domestic Customers
- Charge customers for Domestic Septic Tank Desludging
- Recover the cost of Roads Drainage from all customers.

Following an analysis of consultation responses and a decision by the Secretary of State, an implementation pathway for the preferred option(s) may need to be established. This will be in conjunction with key stakeholders, and will involve developing in greater detail the costs, timelines, relief schemes and impact mitigations inter alia for further consideration and consultation.

# 2C. If the Policy, Strategy, Plan or Public Service is likely to impact on people in rural areas <u>differently</u> from people in urban areas, please explain how it is likely to impact on people in rural areas differently.

As outlined, high level options have been developed at this point. However, initial analysis indicates that charges may impact negatively on people living in rural areas differently from people in urban areas in some respects. For example, Septic Tank systems are common in rural properties and introducing charges for desludging may impact more on people living in rural properties.

The DAERA Key Rural Issues NI 2022 report found that:

- Rural pensioners were substantially more likely to be in relative or absolute poverty than their urban counterparts.
- The cost of living tends to be higher in rural areas.
- As of Quarter 3 in 2022, average house prices are substantially (17%) higher in rural than in urban areas – one of the options considered in calculating the domestic water charge is the capital value of a property.

Following consultation and analysis of consultation responses it is likely that preferred options will require individual and specific consideration in respect of impact on rural populations especially if options in respect of Removal of the Domestic Allowance and charging customers for Domestic Septic Tank Desludging are being progressed.

## SECTION 4 - Considering the Social and Economic Needs of Persons in Rural Areas

### 4A. Please provide details of the issues considered in relation to the social and economic needs of people in rural areas.

The "<u>Key Rural Issues 2021</u>" report by the Department of Agriculture, Environment, and Rural Affairs' (DAERA) identifies a number of key domains in which there are particular impacts for those living in rural areas. The report identifies the following factors impacting across a range of domains:

- Rural pensioners were substantially more likely to be in relative or absolute poverty than their urban counterparts.
- The cost of living also tends to be higher in rural areas. For example, the relative lack of public transport options and greater reliance on private transport also has cost implications for rural dwellers. As noted in the report, 92% of rural households have access to at least one private vehicle as compared to 78% of urban households (figure 47, page 44). The report notes that this higher level of private vehicle ownership (arguably a necessity) represents a larger cumulative impact on living costs for people who live in rural areas.
- As of Quarter 3 in 2022, average house prices are substantially (17%) higher in rural than in urban areas – the capital value of a property could be a means of calculating the domestic water charge.

These factors together with the option to introduce charges for desludging of Septic Tanks, would suggest that the introduction of water charges may have particular impact on people living in rural areas and, as such, are likely to require significant further consultation and assessment in the context of rural needs. As a mitigation action we are considering a relief scheme and the consultation is seeking views on what that should entail.
