2.1 Legal Advice

2.1.1 Requests for Solicitor's opinion or advice should be forwarded to the Headquarters Branch dealing with the specific subject e.g., Contracts Branch or Lands and Legislation Branch. This will enable any relevant expertise or earlier legal advice available in a Headquarters Branch to be collated with the request

2.1.2 Submissions to Headquarters should be in writing with the full factual background clearly set out. Copies of relevant documents and correspondence should be forwarded and a map, sketch or photograph can be helpful.

2.1.3 Legal opinions and advice which are likely to be of value to other Roads Service Divisions will be circulated. However, advice given in one particular set of circumstances may not necessarily apply to another case and care is necessary in this respect.

2.1.4 Departmental Solicitor's Office in Victoria Hall, 12 May Street, Belfast, BT1 4NL (Tel 251251) may be contacted direct in any matter of extreme urgency.

21.5 Enquiries about the interpretation, working etc., of the legislation under which Roads Service operates should be made in the same manner as indicated above.

2.1.6 It should be noted that full Notes of Articles in respect of the Roads (NI) Order 1993, the Street Works (NI) Order 1995 and the Road Traffic Regulation (NI) Order 1997 have been made available to Divisional Roads Managers. Reference to these notes may obviate the need to submit enquiries to Headquarters in some instances. Notes on Articles are also held in Roads Service HQ.
