

SPEED LIMITS

The Department for Regional Development has made a Statutory Rule entitled The Moyallan Road, Portadown and College Lands Road, Charlemont (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2016 (S.R. 2016 No. 39) which will come into operation on 3rd March 2016.

The Order will introduce a part-time speed limit of 20 miles per hour on a length of **College Lands Road, Charlemont** adjacent to St. Peter's Primary School and **Moyallan Road, Portadown** adjacent to Moyallon Primary School.

The effect of the Order is that the national speed limit, which is applicable to that length of College Lands Road and Moyallan Road, shall be reduced to 20 miles per hour when a 20 miles per hour limit is indicated by means of a variable message traffic sign.

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Article 38(1) and (2) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Moyallan Road, Portadown and College Lands Road, Charlemont (Part-Time 20mph Speed Limit) Order (Northern Ireland) 2016 and shall come into operation on 3rd March 2016.

Part-time speed limit

2.—(1) A person shall not drive a motor vehicle on the lengths of road specified in the Schedule at a speed exceeding 20 miles per hour when such speed limit applies to those lengths of road in accordance with paragraph (2).

(2) A 20 miles per hour speed limit applies to the lengths of road specified in the Schedule when a 20 miles per hour speed limit is indicated by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations (Northern Ireland) 1997(d).

SCHEDULE

Article 2

PART-TIME SPEED LIMIT

1.	College Lands Road, Route B28, Charlemont, from a point 190 metres north-west of its junction with Corrigan Hill Road, Unclassified No. 7461, to a point 280 metres south-east of that junction.
2.	Moyallan Road, Route A50, Portadown, from a point 15 metres west of its junction with Ballynagarrick Road, Unclassified No. 1286, to a point 460 metres south-east of that junction.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order introduces a part-time speed limit on the lengths of road specified in the Schedule. The Order permits the national speed limit on the lengths of road adjacent to St. Peter's Primary School, Charlemont and Moyallon Primary School, Portadown to be reduced to 20 miles per hour, when a 20 miles per hour limit is indicated by a traffic sign.
