I would like to request the following information:

- 1. The number of potholes reported per year in the last five years (broken down by district/council if possible).
- 2. The number of potholes repaired per year in the last five years.
- 3. The amount of money spent on pothole repairs per year in the last five years.
- 4. The number of compensation claims filed for damage to vehicles or personal injury per year in the last five years.
- 5. The amount of money paid out in compensation per year in the last five years.

Response (issued 27 April 2023)

Thank you for your information request dated 29 March 2023. I note that you requested the following:

- 1. The number of potholes reported per year in the last five years (broken down by district/council if possible).
- 2. The number of potholes repaired per year in the last five years.
- 3. The amount of money spent on pothole repairs per year in the last five years.
- 4. The number of compensation claims filed for damage to vehicles or personal injury per year in the last five years.
- 5. The amount of money paid out in compensation per year in the last five years.

As Head of Roads Claims Unit, your information request has been referred to me to address on behalf of the Department for Infrastructure.

In considering your information request on behalf of the Department, I have determined that the information requested falls under the aegis of the Environmental Information Regulations 2004.

I can confirm that the Department for Infrastructure does hold information related to your request. As EIR relates to public rights of access to information, I must consider whether information is suitable for release to the world at large and not solely to the applicant. I have examined the information you requested and carried out a public interest test to determine whether the information is suitable for release to the public.

I can confirm that the information requested is available. Some of the information requested has been presented below or overleaf. Alternatively, directions have been provided on where the other information can be found within the public domain. Please note, however, that: -

- The Department maintains information relating to road surface defects by Roads Section
 Office areas which broadly align with Council areas.
- ii. The Department maintains financial information by Financial Year. Therefore, the figures presented in the tables are the full financial years 2018/19 to 2021/22. However, the figures presented for the financial year 2022/23 are estimated as accounts have not been finalised yet and the figures may be subject to change.
- iii. The road maintenance expenditure figures have been determined by budget availability and capacity in a given year.
- iv. The figures presented in Table 4 represent total expenditure on compensation paid to claimants for roads related vehicle damage and personal injury claims.
- v. Claims received in a financial year are not always concluded in the same financial year. Therefore, the compensation figures presented in Table 4 include compensation for claims received in prior financial years.
- vi. Financial figures have been presented by rounding to the nearest million pound.

For each of your questions, I can answer as follows:

1. The number of potholes per year in the last five years.

2. The number of potholes repaired per year in the last five years.

The datasets at 1 and 2 above can be downloaded as an Excel spreadsheet and sorted/filtered to access the specific information you requested.

3. The amount of money spent on pothole repairs per year in the last five years.

The cost for repairing potholes falls within the Department for Infrastructure's budget for "patching". This term is applied to small scale works including infilling potholes and repair of small areas affected by cracking or settlement.

Table 1, below, sets out the amount of money the Department has spent on the repair of carriageway patching from 2018/19 to 2022/23.

Table 2, below, provides Structural Maintenance expenditure (which also includes carriageway patching expenditure) on the road and footway network across NI analysed between capital and resource for the financial years 2018/19 to 2022/23.

Capital Structural Maintenance is the collective term for expenditure on resurfacing, surface dressing, asphalt patching, structural drainage and structural stability of the road network and Resource Structural Maintenance includes mainly patching with some carriageway refurbishment.
