**The On-Street Parking (Amendment) Order (Northern Ireland)
2023**

Made - - - - *22nd February 2023*

Coming into operation *1st April 2023*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 15(1) and 16(1) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

Citation and commencement

1. This Order may be cited as the On-Street Parking (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 1st April 2023.

Amendment

2. The On-Street Parking Order (Northern Ireland) 2000^(d) is amended by the substitution for Part 4 of Schedule 1 of the Part 4 set out in the Schedule to this Order.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order further amends the On-Street Parking Order (Northern Ireland) 2000 (“the Order”) by revising the charges applicable to on-street parking in Belfast, Lisburn and Newry.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and the Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
