The River Sillees Bridge Order (Northern Ireland) 2021

Made - - - 8th July 2021

Coming into operation - 12th August 2021

The Department for Infrastructure (a) in accordance with Article 4 of the Roads (Northern Ireland) Order 1993(b) proposes by order to provide for the construction of a bridge over the navigable waters of the River Sillees, Enniskillen.

The Department has taken into consideration the reasonable requirements of navigation over the waters affected by the order in accordance with Article 4(3) of that Order.

The Department has published and served a notice in compliance with paragraphs 1 and 2 of Schedule 8 to that Order.

In the absence of any objections being set before the Department during the statutory consultation period, the Department decided to proceed without subjecting the scheme to an examination through a public inquiry.

The Department makes the following order in exercise of the powers conferred by Article 4 of the Roads (Northern Ireland) Order 1993 and now exercisable by it(c).

Citation, commencement and interpretation

- **1.** This Order may be cited as the River Sillees Bridge Order (Northern Ireland) 2021 and comes into operation on 12 August 2021.
 - 2. In this Order—

Articles 2

POSTION AND DIMENSIONS OF THE RIVER ERNE BRIDGE

The bridge is located over a section of the River Sillees in association with the construction of the A4 Enniskillen Southern Bypass scheme.

Points of Commencement and Termination

The Bridge is to cross from the townland of Mullylogan at the newly formed Derrylin Road roundabout on the West bank (OS Ref 222630, 342255) (marked A on Drawing 1) over to the townland of Gortadrehid Little on the East bank (OS Ref 222660, 342250) (marked B on Drawing 1).

Navigation Waterway

Single waterway, minimum 21.530 metres wide between abutments marked C and D on the main span as shown on Drawing 1. Navigation is also provided under the adjacent areas of the main span as shown on Drawing 1 as approved by Waterways Ireland and marked E and F on Drawing 1

Headway

Headway clearances are indicated on Drawing 1 measured as above ordnance datum (AOD), 1 in 100 year flood level. A headway minimum of 2.30 metres is provided over a width of 21.530m and marked C and D on Drawing 1.

EXPLANATORY NOTE

This order provides for the construction of a bridge over part of the navigable waters of the River Sillees in association with the A4 Enniskillen Southern Bypass scheme.
