# **ROAD TRAFFIC AND VEHICLES**

# The Parking Places (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2022

Made	-	27th January 2022
Coming into operation	-	21st February 2022

The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

#### **Citation and commencement**

**1.** This Order may be cited as the Parking Places (Disabled Persons' Vehicles) (Amendment) Order (Northern Ireland) 2022 and shall come into operation on 21st February 2022.

## Unlimited Waiting

"2984.	Ardcarn Green, Belfast (north-side in a parking area opposite No. 2) – from a point 15 metres west of its junction with Ardcarn Park for a distance of 3 metres in a westerly direction.
2985.	Greenore Street, Belfast (north side) – from a point 35 metres west of its junction with Woodstock Road for a distance of 5.5 metres in a westerly direction.
2986.	Willowfield Gardens, Belfast (north-east side) – from a point 68 metres north-west of its junction with Jocelyn Gardens for a distance of 5.5 metres in a north-westerly direction.
2987.	Benview Road, Coshquin (south east side in a layby) - from a point 98 metres south-west of its junction with Buncrana Road for a distance of 3 metres in a south- westerly direction.
2988.	St. Dympna's Park, Downpatrick (south side) – from a point 50 metres south of its junction with Oriel Drive for a distance of 2.4 metres in a southerly direction.
2989.	Kinnegar Road, Holywood (south east side) - from a point 80 metres south-west of its junction with Kinnegar Drive for a distance of 6 metres in a south-westerly direction.
2990.	Lisfannon Park, Londonderry (north-east side of a parking area in front of No. 12) – from a point 106 metres north-east and then south-east and then north-east and then north-west of its junction with Westland Street for a distance of 3 metres in a north- westerly direction."

### EXPLANATORY NOTE

#### (This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2).
