**ROAD TRAFFIC AND VEHICLES**

**The Roads (Speed Limit) (No. 2) Order (Northern Ireland) 2018**

*Made* - - - - *30th August 2018*

*Coming into operation* - *19th September 2018*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Roads (Speed Limit) (No. 2) Order (Northern Ireland) 2018 and shall come into operation on 19th September 2018.

**Application of speed limits**

2. The driving of motor vehicles at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 1 is prohibited.

**Revocations**

3. The provisions described in Schedule 2 are revoked.

## SCHEDULE 1

Article 2

### Lengths of road subject to a speed limit of 40 miles per hour

1. Old Clare Road, Route B2, Clare Village, Tandragee, from its junction with Cloghoge Road, Route B131, to a point 70 metres north of that junction.
2. Clare Road, Route B2, Clare Village, Tandragee, from its junction with Cloghoge Road, Route B131, to a point 70 metres north of its junction with Mavemacullen Road, Unclassified No. 7772.
3. Cloghoge Road, Route B131, Clare Village, Tandragee, from a point 50 metres south-east of its junction with Markethill Road, Route B3, to its junction with Clare Road, Route B2.
4. Cloghoge Road, Route C173 Clare Village, Tandragee, from its junction with Clare Road, Route B2 to a point 25 metres west of its junction with Ballyshiel Road, Route C174.
5. Rathfriland Road, Route A25, Newry, from a point 260 metres south of its junction with Glenvale Road, Route C339, for a distance of 660 metres in a north-easterly direction.

## SCHEDULE 2

Article 3

### Revocations

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order—

- (a) applies a speed limit of 40 miles per hour to the lengths of road specified in Schedule 1;  
and
- (b) revokes the provisions in Schedule 2.

In relation to the revoked provisions in Schedule 2—

1. The speed limit on the length of Clare Road, Clare Village, Tandragee (item 118 of Schedule 2) is now set at 40 miles per hour.

2. The speed limit on the length of Cloghoge Road, Clare Village, Tandragee (item 119 of Schedule 2) is now included in a longer length of road set at 40 miles per hour.
