The Department for Infrastructure(**a**) makes the following Order in exercise of the powers conferred by Articles 37(3), 37(4) and 38(1)(a) of the Road Traffic Regulation (Northern Ireland) Order 1997(**b**) and now vested in it(**c**).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 5 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Roads (Speed Limit) (No. 4) Order (Northern Ireland) 2020 and shall come into operation on 10th December 2020.

Application of speed limits

2. The driving of motor vehicles at a speed exceeding 40 miles per hour on the length of road specified in Schedule 1 is prohibited.

Revocations

3. The provisions described in Schedule 2 are revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order—

- (a) applies a speed limit of 40 miles per hour to the length of road specified in Schedule 1; and
- (b) revokes the provisions in Schedule 2.

In relation to the revoked provisions in Schedule 2 the speed limit on the lengths of Ballagh Road, Fivemiletown (paragraphs 1 and 2 of Schedule 2) are now included in a longer length of road at 30 miles per hour (restricted by street lighting).
