

## **TAXIS - LONDONDERRY**

The Department for Infrastructure has made a Statutory Rule entitled The Taxis (Londonderry) (Amendment) Order (Northern Ireland) 2017 (S.R. 2017 No. 133) which will come into operation on 21st July 2017.

The order will introduce a taxi stand on a length of **Lower Clarendon Street, Londonderry**. Vehicles are excepted from the restriction in certain circumstances.

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 27A(1) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4A to that Order<sup>(d)</sup>.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

Two objections were received and duly considered.

The Department has modified the Order to take account of the objections.

**Citation and commencement**

1. This Order may be cited as The Taxis (Londonderry) (Amendment) Order (Northern Ireland) 2017 and shall come into operation on 21st July 2017.

**Amendment**

2.—(1) The Taxis (Londonderry) Order (Northern Ireland) 2010<sup>(e)</sup> is amended in accordance with paragraph (2).

(2) For the Schedule substitute the Schedule specified in the Schedule to this Order.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order adds the item in the Schedule relating to Lower Clarendon Street to the locations which may be used as stands for taxis in the city of Londonderry, the maximum number of taxis which may use that stand and the hours available for use.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
